Booking Contract

Host designates that <name> will serve as its official representative for all communication pertaining to this event between Host and ASHGI's representatives. Host's representative can be contacted via <phone number>, <e-mail address>, and <cell phone number>. Host verifies that this representative is authorized to act for Host on all matters pertaining to this event. Host acknowledges that statements made by its representative shall be construed as fully approved, backed by, and accepted by Host.

Booking Fee – A booking fee of <amount> will be submitted with this signed contract.

Event Costs, Supplies and Equipment - Host will cover all costs related to the event facility. At its own expense, Host will provide and pay for all necessary equipment and supplies including, but not necessarily limited to, those listed in "Presenting C.A. Sharp's Seminars," as appended.

Host acknowledges that it is fully responsible for acquisition and successful operation of any necessary projection equipment used for the event.

Travel, Lodging and Meals – Speaker will be traveling to this event by <transport type>.

If transport is by air or train, Speaker will make her own travel arrangements. Before purchasing tickets, Speaker will verify with Host's designated representative that the cost is acceptable. If Speaker's transport is by car, Host will reimburse Speaker for round-trip travel at the Internal Revenue Service-designated mileage reimbursement rate as of the event date.

Host will provide lodging and meals for Speaker from her arrival at her inbound transportation hub and until she is delivered to her departing transport hub. If Speaker does not come by car, Host is responsible for all ground transport while Speaker is there.

Cancellation – If Host should cancel the event and Speaker has already purchased airline tickets for the event, Host remains responsible for the cost of those tickets. If Host cancels thirty (30) days or more prior to the event, the booking fee will be returned.

If ASHGI or Speaker cancel the event, the booking fee will be returned. If Host has already paid for transport, that amount will also be returned.
